Subject: **2024 Global Quality P4P Program – Manifest MedEx (MX) Connectivity Reminder**

Inland Empire Health Plan (IEHP) would like to remind you of the 2024 Global Quality P4P (GQ P4P) measure requirements for Manifest MedEx (MX) Connectivity.

This is the third year of the Manifest MX Connectivity measure and Providers are encouraged to participate in Manifest MX to help IEHP increase PCP connections with an aim to improve patient care and coordination.

The five (5) milestones of the MX Connectivity measure are as follows:

For PCPs without an established MX Connection*:

- **Milestone 1:** Get Connected to Manifest MedEx!

For PCPs already established with MX*:

- **Milestone 2:** Stay Connected to MX
- **Milestone 3:** Improve Data Quality - Reporting Minimum Data Requirements
- **Milestone 4:** Improve Data Quality - Reporting Clinical Data Elements
- **Milestone 5:** Improve Data Quality - Behavioral Health Data Elements

Meeting these milestones will add additional PMPM to your overall GQ P4P Quality PMPM rate!*

- Eligible milestones 1 – 3 will add an additional \$0.25 to your 2024 Quality PMPM.
- Milestone 4 will add an additional \$0.50 to your Quality PMPM.
- Milestone 5 is a reporting measure only for the 2024 performance year.

**Providers eligible for milestone 1 cannot participate in milestones 2-5, cited above, for the 2024 performance year. Providers who established their MX connection in the 2022 or 2023 performance years are eligible for milestones 2-5.*

Signing Up with Manifest MedEx:

★ **Providers who have not established a connection with Manifest MX can earn incentive dollars for the Manifest MX Connectivity measure in the 2024 performance year.** The requirements below must be met to be eligible to earn incentive dollars for this measure. *Please note the participating agreement completion required by June 1, 2024.*

Manifest MedEx Connectivity



Measure Description:

Participating Providers are encouraged to connect their electronic health record (EHR) systems to the regional Health Information Exchange, Manifest MedEx.



Measure Requirements:

1. Sign a participation agreement with MX by **June 1, 2024**.
2. Establish data connections with MX that includes routine reporting of CCDAs by **December 31, 2024**.
