**Subject:** **REMINDER: 2024 Global Quality P4P Program – CAIR2 Participation Requirement**

Thank you for participating in the **2024 Global Quality P4P (GQ P4P) Program**. We appreciate your partnership in ensuring Members receive quality preventive services necessary to support optimal care and vibrant health.

**REMINDER:** To participate in the 2024 GQ P4P Program, it is required that **PCPs be connected to CAIR2 and demonstrate entry** of immunizations into the registry, **no later than July 1, 2024**. IEHP will confirm PCP connectivity through patient records in the CAIR2 system.

**PCPs who are not connected and do not have immunization records entered in CAIR2 by July 1, 2024, will not be eligible to receive incentive dollars from the GQ P4P Program.**

No further action is required for PCPs already connected and entering immunization records.

### **Why is CAIR2 Participation a Requirement for 2024 GQ P4P?**

- CAIR2 is key to centralizing patient immunization records, allowing Providers to access all immunization records during patient care.
- DHCS has included this requirement for all PCPs as part of the Facility Site Review (FSR) Audit, as noted in the All-Plan Letter (APL 20-006).

### **How Will We Know if Our Practice/Physician Has Met the Participation Requirement?**

- A CAIR2 participation status indicator will be added to the 2024 monthly interim reports, acknowledging IEHP can see new immunizations submitted to CAIR2 by the Provider. Your office should start receiving the 2024 GQ P4P interim reports beginning in February 2024.
- IEHP will continue to send out monthly interim reports to show updated data on Provider performance relating to the 2024 GQ measures.
