SAI360 is a governance, risk management, and compliance (GRC) System that we use for policy and procedure organization, and management.


Access to SAI360 makes it easy to find Provider policies and procedures by line of business, section, and advanced search options.

How to use SAI360

Accessing the link above will direct the user to the IEHP Provider Manual Dashboard. The available options will assist in navigating to the essential pages and modules.



1. Keyword Search Bar:

Search by using one of these methods:


- policy title
- policy description
- or the contents of each file for the keyword entered

2 . Advanced Search Options:

Search across various manuals

- Folder selection
- Description of most recent change
- Degrees of change
- Days since revision

3. Search: After entering keywords, click to search.



- **4. Provider Manuals Catalog:** Click on the > beside each manual to expand and select a section: IEHP DualChoice, Medi-Cal, IEHP Covered (CCA), and Electronic Data Interchange.
- **5. Policies Folder:** Folder Select/Info Identifies the respective Provider Manual and Product
- 6. Policy Number
- 7. Title: Policy Title
- 8. Degree of Change: Minor, Moderate, Substantial, Replacement, New, Retired
 - a. **MINOR:** Punctuation corrections, mostly grammatical in nature, or involve changes in terminology for consistency throughout the manual
 - b. **MODERATE:** Mostly procedural and/or operational clarifications of existing processes
 - c. **SUBSTANTIAL:** Major revisions or a complete rewrite of a policy, or reflect changes that affect the Delegate, Provider or PCP operationally, such as a change to a reporting timeframe or standards
 - d. **NEW:** New Policy effective date
