New CDA Form IMS 36

The CBAS Program announces an updated *Provider Participation Agreement (CDA Form IMS 36)* that includes language supporting *Electronic Visit Verification (EVV)*, a federally mandated system to reduce fraud in Medicaid, established by the 21st Century Cures Act.

In California, EVV regulations are found in the Welfare and Institutions Code Section 14043.51. CBAS centers must comply with EVV by adopting the updated IMS 36, reaffirmed every two years during recertification.

EVV Self-Registration Tips

CBAS centers must self-register to use the EVV system. The CDA has a user-friendly EVV webpage with guidance, including the *"Provider Self-Registration Portal."*

When registering, select the CDA option for payer association and create an additional payer association with DHCS if you have Fee for Service participants. Utilize the step-by-step videos and guides for the registration process.
