Subject: **2024 and 2025 Global Quality P4P PCP Program Guide - Updates!**

Inland Empire Health Plan (IEHP) has made the following updates to the **2024 and 2025 Global Quality (GQ) P4P PCP Program**, as follows:

PROGRAM UPDATE:

- Eligibility and Participation:
 - Medi-Cal Membership Requirement: To be eligible for incentive payments in the 2024 and 2025 measurement years, Providers must have at least 200 Medi-Cal Members (per Provider location) assigned as of July **AND** December of the measurement year.

MEASURE UPDATE:

- Asthma Medication Ratio (AMR):
 - Updated the AMR measure description with additional criteria to help identify the eligible population in the 2024 and 2025 measurement years.
- 2025 Adult Hepatitis B Vaccine:
 - Effective immediately, the Adult Hepatitis B Vaccine measure will be a **monitoring only measure for measurement year 2025** and will become scorable in measurement year 2026.
- Childhood Immunizations (CIS-E) – Combo 10:
 - Effective immediately, **code 90656 has been added** to the CIS-E – Combo 10 measure for measurement years 2024 and 2025. Please see the code details below:

Flu Vaccine	CPT	90656	Influenza virus vaccine, trivalent (IIV3), split virus, preservative free, 0.5 mL dosage, for intramuscular use for intramuscular use

- 2025 Health Equity – Child and Adolescent Well-Care Visit (WCV)
 - The WCV measure within the Health Equity domain is based on the specifications published by the National Committee for Quality Assurance (NCQA) for reporting race/ethnicity data in HEDIS measures and focuses on the white race.
 - Tier 1 goal changed from 48% to 47% for **only measurement year 2025**.

QUALITY BONUS SERVICE (QBS):

- Pediatric Immunizations Administration:
 - Effective immediately, **code 90656 has been added** to the QBS – Pediatric Immunization Administration for performance years 2024 and 2025.
 - Pediatric Immunization services submitted with code 90656 will be eligible for the Quality Bonus Service payment for flu immunizations given 9/1/2024 and forward.

ADULT IMMUNIZATION REIMBURSEMENT:

- Effective immediately, **code 90743 has been added** to the adult immunization reimbursement for the **2025 performance year**. Please see the code details below:
